RESOLUTION No. 15-2022

A Resolution of the Board of Commissioners of the Port of Skamania County Accepting and Approving the 2023 Property Tax Levy

Recitals

WHEREAS, the Port of Skamania County Board of Commissioners has properly given notice of a public hearing held November 15, 2022 to consider the budget of the Port of Skamania County for the 2023 calendar year pursuant to RCW 84.55.120; and

WHEREAS, the Port of Skamania County Board of Commissioners after hearing and duly considering all relevant evidence and testimony presented, has determined that the Port District does not require an increase in revenues from the regular property tax levy from the previous year, and does not require the increase in property tax revenue resulting from the addition of new construction and improvements to property, or any increase in the value of state assessed property in order to discharge the expected expenses and obligations of the Port of Skamania County, and

WHEREAS, the population of the Port District is less than 10,000;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE PORT OF SKAMANIA COUNTY that the Board authorizes a regular property tax levy for 2023 of \$345,421.52, which is an increase of \$3,420.02 and 1 percent over the \$342,001.50 collected in 2022, plus an increase amount, resulting from the addition of new construction and improvements to property, of \$7,842.37, and an increase amount in the value of state assessed property of \$2,037.93.
