Preliminary Budget Review:

Teitzel Lease - Skamania Lawyer, PLLC - Donald Collins

Commissioner Kingston made a motion; Commissioner Broughton seconded the motion to ratify the month-to-month Skamania Lawyer, PLLC lease as presented for the North Bonneville lease Suite C-1 located in the Teitzel building for a monthly lease rate of \$175.00 plus Washington State Leasehold tax in the amount of 12.84% effective October 5, 2023. The Commission acknowledges that the security deposit is less than the 1-year statutory requirement. All voted in favor and the motion carried unanimously.
